The role

The Health and Nutrition Advisor Health technically manages the health / Nutrition programme of Save the Children in CAR, under the supervision of the Director of Program Development and Quality.

His responsibilities include overseeing the evaluations, updating and implementation of sectoral strategy for health and nutrition, technical supervision of the programme and staff, developing proposals, and reports writing.

His responsibilities also include the representation of Save the Children at the national level for high-level coordination with government and other partners, including advocacy for universal access to health care and health system strengthening.

As health and nutrition intervention is integrated into a multi-sectoral approach with HIV, protection, and education, the Health and Nutrition Adviser in coordination ensures the integration of project activities with the relevant sectors.
